

The Catholic University of America – Office of Career Services NACELink Privacy Statement

The Catholic University of America's (CUA) Office of Career Services (OCS) provides access to the NACELink Network web site, which is owned and operated by the National Association of Colleges and Employers (NACE). CUA's Office of Career Services and NACE are committed to maintaining the privacy of personal information provided by students, alumni and employers as participants of OCS.

Employers use NACELink Network to post employment opportunities and search the central resume database directly on NACELink.com, through the CUA OCS web site or NACE's web site (NACEWeb), where there is a direct link to NACELink Network. CUA is a NACELink Custom School and uses NACELink Network to provide a web-based system for posting jobs, maintaining a resume database, registering its job seekers and for the employers who recruit at CUA. Students/alumni use NACELink Network through their college/university career centers to post resumes and review job opportunities.

NACE's commitment to all participants—schools, employers, students/alumni—is to maintain the confidentiality of all information collected on NACELink Network and NACE will not sell, transmit, or disclose, in any fashion, this information to any other organization. NACELink Network is the host server, storing and maintaining the data. NACE also has a partner, Simplicity, which will provide backup hosting services to NACE's servers and is as committed to privacy as NACE. NACE and Simplicity have access to the data in aggregate form.

Students and Alumni

Personally identifiable information that is collected will be used to enable registered employers to access and use the various features of the NACELink Network system, such as posting jobs, scheduling interviews, and using resume search engines. Students/alumni will be able to access the various features of the NACELink Network system, i.e., job posting, resume databases, and job-search agents. Communications with employers will be enhanced regarding use of NACELink Network, site changes, or information on possible events/activities associated with recruiting.

NACE receives and collects personal identifiable information about a student/alumni participant, (name, contact information, demographic information, academic history, employment history, etc.) via NACELink Network after the participant registers for services and uploads resumes, cover letters, and other documents containing personal information.

OCS may access some of the job seeker's personal information in order to send e-mail using communication tools on the site, to publish resumes in the school's resume book(s), and to send resumes to registered employers on behalf of the students/alumni.

Employers

Employers that use NACELink Network directly through NACELink or through CUA's OCS will have access to participants' resumes and the personal information contained

therein for recruiting, interviewing, and hiring purposes. Employers will also have access to limited information from participant's profiles only if the profile matches an employer's search criteria. NACE and CUA are not responsible for what employers do with the personal information that is available or accessible on this site.

While NACE endeavors to restrict access to this database to eligible employers, NACE cannot guarantee that other parties will not, without consent, gain access to the database. NACE will collect information from employers utilizing the site, such as contact information (phone numbers or e-mail addresses), unique identifiers (NACE membership, account numbers, or passwords to NACELink Network), financial information (credit card numbers), and demographic information (location, type of organization, size of organization). The financial information collected will be used only to bill an organization for associated fees. Credit card information will be deleted as soon as the transaction is completed and will not be stored on NACE's or Simplicity's servers.

Updating and Internet Protocol (IP) Addresses

NACELink Network allows participants to change or correct personal information at any time. To do so, participants simply login to their account, go to their profile and locate options for editing the information. NACE collects IP addresses from all participants of the site, and collects and monitors other data and information about the activities of participants on the site collectively. This data is used anonymously and in the aggregate.

Cookies

Cookies, which are small text files recorded in a participant's hard drive, are employed by thousands of sites to enhance participants' web viewing experience. Cookies allow sites to "remember" participants across pages of a site and across multiple visits to a site. When participants access NACELink Network, it will set a cookie while they are on the site. Once participants log out of the site or close their browser window the cookie is deleted. Thus, NACELink Network will not store information as to the number of times a participant visits the site. It will be necessary for participants to log in each time they access NACELink Network.

Security

NACE takes precautions to protect the participant's information. When participants submit sensitive information via the Web Site, the information is protected both online and off-line. In addition, the job seeker and employer data is password protected, so only the participant can access this information. All personally identifiable information collected by NACE is stored in limited-access servers. NACELink Network uses firewalls and has technical, administrative, and physical security measures and safeguards in place to protect against the loss, misuse, and alteration of the information under NACE's control.
